IFEH 2010 Introduction to Healthy Built Environment (HBE) September 8, 2010

Location: Cypress Room, Westin Bayshore Hotel

Objective

To provide an introduction to the healthy built environment, identify the role that environmental health professionals can play, discuss case studies, and share tools that can be applied to other international settings.

Workshop Description

The first half of the morning session will consist of a workshop to introduce the topic of healthy built environment and its impact on public health; to share initiatives in British Columbia, Canada and other countries; to discuss barriers and next steps. Participants will be asked to share their own experiences in the built environment. Case studies of promising built environment projects, that have involved PH and community planners, will be presented. The afternoon will consist of a boat tour around False Creek to observe first-hand the results of promising community planning initiatives. Participants will be dropped off at Granville Island at the end of the tour or they can return to the Westin Bayshore.

Learning outcome

Participants will become familiar with how built environment impacts health, learn about various built environment initiatives, and will be able to apply some of the lessons learned to their own jurisdictions.
